What is the State Revolving Fund (SRF) Loan?

- Advance Payment: Less impact on the budget
- 25-percent forgiveness of overall loan
- Loan paid through utility fund rate increases of nine-percent annually over five years
- First payment due on May 15, 2026



Cherry Street

(Ward I, Cove)

Under Construction - Two Phases

- Replacement and upgrade of drinking water, portions of the gravity sanitary sewer and segments of the stormwater systems
- Pavement of roadway and addition of wider sidewalk and bike path
- Contractor – Royal American Construction
- Construction Costs, funded by SRF
 - Phase I - \$6,058,154
 - Phase II - \$5,534,195



Area U

(Ward I, Cove)

Under Construction – Two Phases

- Replacement and upgrade of drinking water, replacement and/or structural lining of portions of the gravity sanitary sewer and replacement of segments of the stormwater sewer
- Pavement of roadway and addition of sidewalk (where right-of-way space allows)

Contractor

- Phase I - Royal American Construction
- Phase II - Marshall Brothers Construction

Construction Costs, funded by SRF

- Phase I - \$4,430,018
- Phase II - \$13,597,484



Area S

(Ward II, Glenwood)

Under Construction

- Replacement and upgrade of drinking water, replacement and/or structural lining of portions of the gravity sanitary sewer and replacement of segments of the stormwater sewer
- Pavement of roadway and addition of sidewalks (where right-of-way area allows)

Contractor - Mainline Construction

Construction Cost, funded by SRF - \$5,323032

(Ward III, Venetian Villa)

Section F-1 – Construction Contract Awarded

Contractor – Gulf Coast Utility Contractors

Construction Cost, funded by SRF - \$6,457,228.

- Replacement and upgrade of drinking water system, replacement and/or structural lining of portions of the gravity sanitary sewer system and replacement of segments of the stormwater system






Baker Court

In Design and Engineering (90%), Seeking Construction Funding

- Replacement and/or structural lining of portions of the gravity sanitary sewer, replacement of segments of the storm sewer and replacement of drinking water distribution systems.
- Pavement of roadway and addition of sidewalks (where right-of-way space allows)




Area H

- Pavement of roadway and addition of sidewalks (where right-of-way space allows)




Area P-11 and 12

(Ward I, Cove)


Under Design and Engineering (60%), Seeking Construction Funding Source




Project Restore Area A2

(Ward IV, Drummond Park)

Reviewing Construction Bids for Contract Award


- Repair or replacement of approximately 3 miles of damaged sanitary sewer lines, 2.42 miles of stormwater lines, and 2.42 miles of water main lines
- Existing roads and sidewalks disturbed will be replaced
- Allocated Funding
 - **\$20,997,682.18** (100% - CDBG-DR)



Project Restore Millville (Ward I)

Reviewing Construction Bids for Contract Award


- Repair or replace approximately 3.11 miles of damaged sanitary sewer lines, 0.16 miles of stormwater lines and 3.96 miles of water main lines
- Existing roads and sidewalks disturbed will be replaced
- Allocated Funding
 - **\$18,986,552.47** (100% - CDBG-DR)



Project Restore Glenwood (Ward II)

Under Design and Engineering – Task Order Issued

- Repair or replacement of 1.4 miles of damaged sanitary sewer lines, 0.25 miles of stormwater lines and 1.4 miles of water main lines
- Existing roads and sidewalks disturbed will be replaced
- Allocated Funding
 - **\$11,888,559.08** (100% - CDBG-DR)




Project Restore AO

(Historic Downtown)

Under Design and Engineering

- Repair or replacement of approximately 1.75 miles of damaged sanitary sewer lines, 1.75 miles of stormwater lines and 1.4 miles of water main lines
 - Existing roads and sidewalks disturbed will be replaced
 - SRF for design
 - **\$12,738,605.50** (100% - CDBG-DR)



Lift Station And Sewer Hardening

Under Design and Engineering

- Project includes Lift Stations 16, 20, 45, 46, 47, 50, 51A, 70, 71, 75, 78 and 81 (gravity basin)
- Rehabilitation and repairs to lift stations
- Allocated Funding
 - HMGP - \$18,490,116.00(75%)
 - CDBG-DR - \$6,163,372.25 (25%)



Project Storm

Out For Bid

- Construct permanently mounted bypass pumps at up to 60 city lift stations and install a telemetry system at 54 lift stations
- Allocated Funding:
 - **\$24,867,120.96** (100% - CDBG-DR)



Lift Station 16

Under Design and Engineering


- Relocate Lift Station 16 away from St. Andrew Bay and reroute sewer lines. Location of new lift station is to be determined
- Funded by Hazard Mitigation Grant Program funding and Florida Department of Environmental Protection (FDEP) grant



Comprehensive Drainage (Robinson Bayou)

Under Design and Engineering


- Robinson Bayou Drainage Basin expands from the Panama City mall to the west side of the old airport
- Rehabilitate approximately 300 acres of storm ravaged wetlands to provide additional stormwater runoff storage
- Replace at least two downstream culverts near the airport to allow additional flow into Robinson Bayou
- Allocated Funding
 - HMGP - \$17,370,339.75 (75%)
 - CDBG-DR - \$5,790,113.25 (25%)



Sherman Avenue Stormwater Improvements

Under Construction

- Improve drainage to the neighborhood west of Joe Moody Harris Park. The area west of the park experiences stormwater flooding to low lying areas. Proposed improvements shall reduce flooding on roads and structures
 - Project performed in-house by the Public Works Department
 - Funded by Hazard Mitigation Grant Program (HMGP)



FEMA Public Assistance Projects

(Reimbursable Funding)



Outstanding FEMA Infrastructure Projects

- Sidewalks
 - Completed repairs to ~75 segments of sidewalks and curbs, damaged by Hurricane Michael. (\$209,875)
- Drainage Inlets
 - Bid awarded to BCL Contractors, repair of ~100 drainage inlets damaged by Hurricane Michael (Estimated at \$1.5 million)
- Road Damages
 - Scope being negotiated with FEMA on 351 road segments totaling 26 miles of roadway center-lines. (Pending estimation totals)

West Beach Dr. Multi-Use Path

The Florida Department of Transportation was granted funds through a specific Florida Legislature appropriation to award Panama City an \$8 million grant to construct a 12-foot-wide multi-use sidewalk on West Beach Drive from Frankford Avenue to W. 6th Street.

The funds cannot be reappropriated or reassigned.

The project proposes to construct a 12-foot-wide multi-use sidewalk on West Beach Drive from Frankford Avenue to West 6th Street. The goal is to build a scenic waterfront sidewalk along West Beach Drive that increases pedestrian and bike riding connectivity and safety for its users between Downtown Panama City and Historic St. Andrews.



MLK Jr. Rec Center Rebuild

Building Permit Issued on April 30, 2024

Projected Completion: 3rd Quarter of 2025

Completed:

Excavation for the sheet pile wall installation, sheet pile wall installation (cap and waler), ASAP building transformer installation.

Started:

Building pad construction, rammed aggregate pile mobilization

Next:

Complete sheet pile wall coatings, excavation of the building pad construction, rammed aggregate piles for gym building. Start storm water and sanitary sewer installation, start concrete footings for both gym and multi-purpose buildings

Marina Civic Center

- Voted by City Commission to move forward with demolition of the building
- Attempts to salvage anything inside the building were made
- Recently awarded the bid to contractors for demolition, Break-N-Ground
- Future use:
 - Short term: a semi-permanent amphitheater to use as we work to raise funds for our long-term goal...
 - Long-term goal: permanent, indoor performing arts center/events center.

Martin Theater Complex build-out

- Construction bid received for ~\$35,000,000
- Includes refurbishment of the historic Martin Theater
- Also includes partial internal demo of old DIB Building and build-out to The Ritz
- Also includes demo of Green Room and build-out to the Tennessee House
- Staff has been working for ~6 weeks with Burke Construction Group on savings opportunities and value engineering without affecting the scope
- Will be considered by and voted on by the Commission at the June 25th, 2024 meeting

St. Andrews & Downtown Marinas

St. Andrews Marina

- Recently approved to rebuild 50 slips
- Currently ordering materials for construction
- Working on plans for the bulkhead repair

Downtown Marina

- Interim agreement to get the fuel tanks/operations back up and running was approved June 18th, 2024
- Negotiations ongoing with City Marina Partners, LLC
