

## **Hurricane Michael Community Development Block Grant Disaster Recovery (CDBG-DR) Hometown Revitalization Program (HRP)**

Florida Commerce (FC) has allocated funding for the Rebuild Florida Hometown Revitalization Program through the Community Development Block Grant — Disaster Recovery (CDBG-DR) Program by the U.S. Department of Housing and Urban Development (HUD) to address unmet disaster recovery needs related to damage from Hurricane Michael. Federal Register requirements clearly state that funds may be used only for disaster relief and long-term recovery in communities affected by the specified disaster. Requirements provide that fund be directed to areas with the greatest need. All CDBG-DR funded eligible activities must tie to storm damage as specified in and not prior to the Presidential Disaster Declaration 4399 for Hurricane Michael on October 11, 2018.

Projects eligible for funding under this program include:

- Public facility improvements, including streetscapes, lighting, sidewalks, and other physical improvements.
- Acquisition, demolition, site preparation, or rehabilitation or commercial structures carried out by a unit of local government.
- Assistance to small businesses for rehabilitation and physical improvements to their places of business. Façade improvements to private or public structures in commercial area.

The City of Panama City has been awarded \$1,781,236.76 of CDBG-DR funds for local businesses and/or public facilities for repairs and improvements to their facade. from the physical and financial damages suffered from Hurricane Michael. Businesses and/or Public Facilities will be able to obtain assistance in repairing or improving real property, interior and exterior paint, sign replacement, awning replacement, exterior walkway and lighting improvements, roof repairs/replacement, window repair/replacement, and siding repairs or improvements.





replacement, awning replacement, exterior walkway and lighting improvements, roof repairs/replacement, window repair/replacement, and siding repairs or improvements.



include shade trees with soil cells for storm water management, wider sidewalks, bicycle lanes, parallel parking instead of angled parking and narrowed lanes that will increase overall safety.



The City of Panama City has been awarded \$992,308.74 of CDBG-DR funds for Project ACCESS. As a result of Hurricane Sally, the City has experienced significant impacts to local businesses and business opportunities within the St. Andrews Marina area. The docks/piers of the marina have been damaged to a point where businesses utilizing these structures are unable to perform their scope of operations. Damages to these structures have resulted in a trickle-down impact to small businesses supporting and reliant upon the goods and services of the marina-based enterprises.

Construction of this project will include the measures of Project ACCESS will include but not limited to: repair/upgrade of an existing gazebo, installation of new streetscape, utilizes, lighting, landscaping, and public programming enhancements.
